Boxes of Glorcy and The transporter collection (set of 2 discs) that led me to remember that Casey used to take the Bambi movies to Zanny's apartment for Casey to watch.


Casey stated that the rubber football and soccer ball that was with Caylee's belongings someone in the end of may was Annabelle's. (Jellicette Lewis' daughter) Caylee's playmate. Zanny watched Caylee and Annabelle.

Casey was very protective of these toys and kept them on Caylee's dresser because she wanted to return them to Annabelle.

Sometime last year 07 Casey bought an inflatable bed for Caylee to stay over at Zanny's apartment. This bed typically stayed in Casey's trunk of the Pontiac Sunfire; but has been in the house for at least 2 months.

Casey stated to me that the purpose of this bed was for Caylee to sleep in when staying at Zanny's apartment.

The Bambi videos frequently were in Caylee's backpack when she returned from Zanny's apartment. I unpacked them numerous times and would place them back with Caylee's other home videos.
