7                                   **DW – MR. DERRICK WILLIAMS**

8 **YM:** The date right now is November 20, 2009. The time right now is 0954 hours. I'm  
9 Detective Melich, Corporal Melich with the Orange County Sheriff's Office. This  
10 is reference to Orange County case number 08-074777. I am also present with  
11 uh, Sergeant Duane Mason. Uh, also present with a Derrick Williams. Is that  
12 correct?

13 **DW:** Yes.

14 **YM:** And Derrick, would you please state your name and birthday for the record?

15 **DW:** Derrick Williams. 05/08/79.

16 **YM:** Okay. You understand this is being recorded Derrick?

17 **DW:** Yes.

18 **YM:** Any objection to that?

19 **DW:** Huh-huh (negative).

20 **YM:** Derrick, we've been uhm, talking on the phone back and forth. Long story short  
21 is that we came upon back in June a uh, I know it's probably before that you  
22 posted it, a You Tube statement basically saying that a lot of people were talking  
23 about you, and you wanted to come clear as far as what you knew about the  
24 case, if anything, and you wanted to kind of put it out there as to uhm, what you  
25 may or may not have known about Caylee Anthony.

1 **DW:** Uh-hum (affirmative).

2 **YM:** Do you know who Caylee Anthony is now?

3 **DW:** Uh, I do from the, from TV.

4 **YM:** Okay. Prior to all this TV hype and her arrest, have you ever met Caylee  
5 Anthony?

6 **DW:** No.

7 **YM:** Or Casey Anthony?

8 **DW:** No.

9 **YM:** Have you ever see Casey Anthony at a club that you can recall?

10 **DW:** No.

11 **YM:** Uh, have you ever seen Casey Anthony outside of a club, or with her child  
12 anywhere that you can recall?

13 **DW:** No.

14 **YM:** And have you ever received any phone calls from Casey Anthony?

15 **DW:** No.

16 **YM:** Have you ever received any text messages from Casey Anthony that you know  
17 of?

18 **DW:** No.

19 **YM:** Okay. At some point in time did you live at the Sawgrass Apartments?

20 **DW:** Yes, I did.

21 **YM:** What was your address at Sawgrass?

22 **DW:** Uhm, I lived at three different apartments there. I lived there for a total of three  
23 years. Uhm, from '03 to '06.

24 **YM:** And what, at what time did you live at what apartments? Can you kind of walk  
25 me through?

1 **DW:** Uhm, '03 to uh, June '03, when I first moved down here from New York I lived in I  
2 think it was 214. Uhm, I forgot the exact address, but whatever (inaudible)  
3 2863....

4 **YM:** Okay.

5 **DW:** ...I believe it was. Then I moved from, then the next year I moved to (sighs),  
6 276. I, I think the, it was 2930 or something like that. I'm not quite sure. And  
7 then after that (coughs), in '08, I moved to uh, 314, which is right upstairs from  
8 214. And that was my last residence there. And that was in '08 I believe. No,  
9 oh,.....

10 **YM:** You....

11 **DW:** ....oh, I'm sorry '05.

12 **YM:** You moved there in '0...

13 **DW:** '03 or '05, '03, '04 or '05 I moved there (inaudible), yeah (affirmative).

14 **YM:** Okay. So about, about once a year you would just go to a different apartment?

15 **DW:** Yeah (affirmative), yeah (affirmative), in the last...

16 **YM:** Is there any particular reason for that, or just....

17 **DW:** Oh, well, the first year I, I was a bachelor. So I had my own bedroom, you know.  
18 Then my, my girl moved in with me, who is currently my wife, she moved in with  
19 me. So we went to a two bedroom. Then she got religious and said we shouldn't  
20 be living together before marriage. So then I moved, I moved back to a single  
21 uhm, thing, which is 314.

22 **YM:** Uh-hum (affirmative).

23 **DW:** And, and lived there. I lived at that one for two years. Because then the  
24 following year after we moved apart, we decided to get married, she moved in  
25 with me in June, and we got married in November.

1 **YM:** When did you move out of Sawgrass? Do you remember?  
2 **DW:** Uh, '06. '06. Because we....  
3 **YM:** You moved in in '03?  
4 **DW:** Yeah (affirmative).  
5 **YM:** Uh, in '04 you moved to a different apartment. In '05 you moved back to another  
6 single apartment?  
7 **DW:** And lived in uh, that 314....  
8 **YM:** In....  
9 **DW:** ...for two years.  
10 **YM:** ...'05 to '07?  
11 **DW:** Uh-hum (affirmative).  
12 **YM:** But you say you left in '06. So, how uh, you sure you left uh, Sawgrass in '06?  
13 **DW:** Yeah (affirmative). I mean, '03 to '04, '04 to '05, '05 to '06. '07, that, yeah  
14 (affirmative). It was '07 I left.  
15 **YM:** So you left in '07?  
16 **DW:** Yeah (affirmative).  
17 **YM:** Okay. And when you left in '07 you moved to, uh, so did you I...still live in  
18 Sawgrass or?  
19 **DW:** No, I moved down the block to uh, Metro at Michigan, to a condo.  
20 **YM:** Okay.  
21 **DW:** That was 1940 South Conway Road. I've always lived on South Conway Road.  
22 **YM:** And the address, that address on your old license....  
23 **DW:** (Unintelligible – talking over one another) Metro....  
24 **YM:** ...it looks like 1940 South Conway?  
25 **DW:** Yeah (affirmative). Yeah (affirmative), that's Metro at Michigan.

1 **YM:** Apartment one?  
2 **DW:** Uh-hum (affirmative).  
3 **YM:** Okay. And then you, you never went back to live at Sawgrass?  
4 **DW:** No.  
5 **YM:** Have you ever had any uh, I understand you're into uhm, uhm, uh, music and all  
6 that.  
7 **DW:** Yeah (affirmative).  
8 **YM:** Have you ever had any uhm, events at the Fusion Night Club?  
9 **DW:** No, I've never been to the Fusion Ni... Night Club.  
10 **YM:** Do you even know where that is?  
11 **DW:** I don't even know where Fusion's at (laughing).  
12 **YM:** Okay. Do you have any idea, or do you know of anyone else who has  
13 information on the Caylee or Casey Anthony case?  
14 **DW:** Uhm, no. I would not know anybody that knows anybody or anything...  
15 **YM:** Okay.  
16 **DW:** ....about Caylee. I never ran across anybody who even knew her.  
17 **YM:** Uhm, out of curiosity while you're at Sawgrass during that timeframe, from '03 to  
18 '07, do you ever recall seeing her or her child there at all?  
19 **DW:** No.  
20 **YM:** Have you ever, uh, do you know of any people that live at Sawgrass, or lived at  
21 Sawgrass, that are connected with Casey or Caylee?  
22 **DW:** No.  
23 **YM:** Okay. You got anything Sarge?  
24 **RH:** Huh-huh (negative).  
25 **YM:** Alright, Derrick, would you raise your right hand for me?

1 **DW:** Uh-hum (affirmative).

2 **YM:** Do you swear and affirm everything you just told me is the truth?

3 **DW:** Yes.

4 **YM:** Okay. The time right now is 0959 hours.

5 **(Interview stops and resumes.)**

6 **DW:** I just want to make sure you cover yourself and (laughs)...

7 **YM:** Oh, we're....

8 **DW:** ... call me back in. (Laughing.)

9 **YM:** We're back on tape. Derrick, you uhm, I had mentioned before we went on tape

10 that that I was going to ask you about the You Tube video. And....

11 **DW:** Uh-hum (affirmative).

12 **YM:** ...I guess uh, we touched on it, but we didn't cover it. The reason you put the

13 You Tube video out there was to do what?

14 **DW:** Oh, well what happened was uhm, when people ran across records of my, my

15 company and my name, uhm, this blog came up. And they were blogging my

16 name because uh, and this was like three months after the blog was up. So I

17 had no idea that they were talking about me in the blog. But a friend uhm, uh,

18 pointed me to it and I was reading it. And they were making connections with me

19 because my old uh, my old address was that address that, that she gave. So

20 when you pull up that address, or anybody that lived there, uhm, my name came

21 up. My company came up. And I guess this was the time where they was

22 talking about her in the club. And then they saw I was in, and they went to my

23 My Space and saw I was in the entertainment business. They was trying to

24 make those connections. And uhm, it was like pages of blogs about me. They

25 was even like taking out my picture up on My Space and posting it and stuff. So I

1 put the, so I put the uh, You Tube up because at first I was just like I'm going to  
2 ignore it. I figured I'd let it go. But I was like man, you know, let me put  
3 something up so people stop accusing me or something. So I just put it up. And  
4 you know, it, it kind of really stopped it because if you look on the You Tube you'll  
5 see all the comments of people like, oh, okay. You know, blaze blah. People  
6 you know on My Space, oh, uh, thanks for giving that comment because we were  
7 on there and you know, we, we were just looking at you're My Space and we  
8 thought, I was like, oh, you know, I had no problem doing that. And it stopped  
9 and it got, it got like twenty-five hundred plays on it. So it was, I guess people  
10 liked it. (Laughs.)

11 **YM:** What was your uh, entertainment company's name?

12 **DW:** Society Entertainment. It's still like same company. We're incorporated in the  
13 state of Florida.

14 **YM:** And the apartment that you say was connected to Casey was 214?

15 **DW:** Yeah (affirmative), it was 2....

16 **YM:** Was that the one?

17 **DW:** ....it was 214 I believe.

18 **YM:** When you walk into the complex where is that apartment in relation to the  
19 building? Because I know the building is right behind the office, correct?

20 **DW:** Y...well, yeah (affirmative). Well yeah (affirmative), yeah (affirmative), they're,  
21 they're connected. So when you walk in the complex you, it's to the, it's the first  
22 building on the right.

23 **YM:** Uh-hum (affirmative).

24 **DW:** Uhm, and my, and my old apartment was uh, the front apartment, the second  
25 floor, the first staircase to go up, and it was right there.

1 **YM:** Okay. So it's that, is that staircase right at the end of the apartments?  
2 **DW:** Uhm....  
3 **YM:** Or is it like apartments at one side, apartments to the other?  
4 **DW:** Yeah (affirmative), yeah (affirmative), it's two apartments on each side. There's  
5 a staircase that goes up.  
6 **YM:** Okay.  
7 **DW:** And you can go either left or right. I was on the left.  
8 **YM:** Okay. But you weren't at that uh, that staircase I guess right at the end of the  
9 apartment where there's only one apartment on top?  
10 **DW:** Hmm? Uh, no, I didn't live there...  
11 **YM:** Okay.  
12 **DW:** ...until the uhm, the, the two bedroom. Uhm, when I moved to the two-two it was  
13 one of those.  
14 **YM:** Apartment 276?  
15 **DW:** Yeah (affirmative), yeah (affirmative).  
16 **YM:** 2930.  
17 **DW:** Yeah (affirmative), it was 276; something like that.  
18 **YM:** But not, in 2863 you didn't live in that end apartment?  
19 **DW:** No, no, not at all.  
20 **YM:** That faced the parking lot?  
21 **DW:** Not at all.  
22 **YM:** Okay. Is there anything else I didn't ask you that uh, you wanted to add?  
23 **DW:** Nope (negative).  
24 **YM:** Okay, and you raise your right hand? Do you swear and affirm what you just  
25 added is the truth?

1 DW: Yes, I do.

2 YM: Okay. Thank you again. And the time is 1002 hours.
