

1 CE And what happened?

2 LT Ah, they just talked and, and after I told 'em I was down there and I told 'em you
3 showed me a photograph of tape. Um, and a picture of Caylee with tape. And
4 they asked me why and I said I didn't know. And um, I don't know exactly what
5 all I said. I didn't say everything.

6 CE Did you go in our direction? Or did you take that upon yourself? That was, that
7 was nothing that law enforcement asked you to do or instructed you to do is my
8 point.

9 LT What to go down to the Anthony's?

10 CE Yes.

11 LT No, I went myself.

12 CE Okay. What was.. when you mentioned the photograph and the image of the
13 tape. Um, what was Cindy's demeanor about that subject? How did she act?

14 LT She wasn't upset or really concerned. Um, she I guess wondered why.

15 CE You say you... you described it ...

16 LT That you requested...

17 CE ...almost as a whimsical laugh like she was laughing...

18 LT Yeah like,,

19 CE (Inaudible)...

20 LT ...why would they do that? you know like a huh!

21 CE Okay, but George didn't have anything to add?

22 LT No.

23 CE No.

24 LT No.

25

1 CE Um, you had stated... I wrote a couple of notes down when we first got here.
2 You said that ah, um, Cindy had asked you if during our line of questioning if we
3 tried to lead you in any particular way. Can...
4 LT Correct.
5 CE ...can you tell me about that?
6 LT Um, she asked me were, were you were leading me. Or, or what you, you both
7 um, had tried to do. And you know I said, nothing they were just asking some
8 questions. I told them that I had a list. They were asking about the table, Kid
9 Finder's table. Um, and I told 'em I had a list of the people that we went down
10 there and I gave them a list of that. Um, and George had told me that he had the
11 list and he could've gave you that too. Or he could've given them that too.
12 Meaning you guys.
13 CE Did he say that he would've been as um, free to give us the information about the
14 tape that he had taken down to the tent?
15 LT No
16 CE Did he make any statements about that?
17 LT No, not a statement about it.
18 CE Okay he just said he would be willing to give us the list of people?
19 LT The list of..
20 CE Not...
21 LT ...people that I had down phone numbers and the names.
22 CE So, he didn't make a similar statement about the tape like, well if they're curious
23 about the tape I will talk to them about that too?
24 LT No.
25 CE Just the phone list?

1 LT Yes.

2 CE Okay. Um, you asked... they asked you if we had asked about a particular name
3 and I think it was Joy Wray.

4 LT Yes.

5 CE Um, who asked you about that?

6 LT Cindy.

7 CE Cindy.

8 LT Yes.

9 CE She was curious whether or not we were asking about Joy Wray?

10 LT Yes. Yes.

11 CE Did she say why?

12 LT No.

13 CE Okay. And um...

14 LT I think that came up when I mentioned Padilla to you guys and we said, yeah we
15 knew him and all that there. I think that's when Cindy asked me if you asked me
16 about Joy Wray.

17 SA Uh-huh. (Affirmative)

18 CE Did ah, you said you'd asked about Roy Kronk.

19 LT Yes I asked Cindy if she had ever seen or talked to Roy Kronk. If... no I asked
20 Cindy 'cause I told her that you guys asked me if Roy Kronk was ever at the ever
21 at the table. If I knew he was at the table. And I said no I never seen him except
22 on TV. And I asked Cindy if she had ever met him or seen him or talked to him?
23 Or if she'd seen him at the table or hanging out at the table. And she told me no
24 she never seen him or talked to him. The only time she seen him was on
25 television.

1 CE So, she didn't say to you that she'd seen him in the neighborhood? Um..

2 LT No.

3 CE Saw him around the house?

4 LT No.

5 CE Saw him, saw him anywhere..

6 LT I don't know if it was George or Cindy. I think it was Cindy, but I don't know, if it

7 was George or Cindy one of 'em told me that he had a friend right down the road.

8 Because I said to them at the time they said that to me. I said well why didn't he

9 go there to go to the bathroom instead of going in the woods across the street

10 from the school? That was my statement to that.

11 CE And what did they say?

12 LT I don't know.

13 CE Okay. Um, also you had mentioned that Cindy had called you back the following

14 day and left you a message that you still have not returned.

15 LT Correct.

16 CE And you, you were nice enough to... I'm sorry go ahead.

17 LT She asked me to either text her or call her. I.. my phone I left my phone in my

18 car that night so I didn't get the message till the next morning.

19 CE Can you play that message for me again please? And you're reluctantly doing

20 so, but I appreciate it.

21 SA There's no point, I mean there's no reason that anybody would have to hide the

22 truth. When they have.. the Anthony's maintained all along all they want I the

23 truth to come out. You ever heard 'em say that before?

24 LT (No verbal response.)

25

1 CE Slide it over here.

2 (Phone message from Cindy Anthony to Linda Tinelli)

3 This is Cindy I just want to let you know that um, I did speak with Brad
4 today, Brad Conway our attorney. About what you told us last night, I just
5 want to let him know the line of questioning that um, John Allen was
6 directing you in. Especially towards George. So, anyway he said he would
7 like to speak with you. You know.. by phone you don't have to go down or
8 anything like that if that'd be alright with you. He'd like to call you. If not
9 tomorrow by Friday he does have a um, a court date tomorrow. He's not
10 sure if he'll be done you know at a reasonable time tomorrow or not to call
11 you. But he said he might be able to finish up early sometimes he does.
12 Otherwise he'd like to try to get you at least by Friday. I just want to make
13 sure it's okay for me to give you... give him your phone number. Okay
14 honey um, so Brad you know he's one of the good guys. I just want to
15 make that we don't get blindsided by anything. I mean I don't trust
16 anybody. Um, not.. not talking about you I'm talking about the sheriff's
17 department. So, anyway honey I love you and just either give me a text and
18 let me know you got the message or give me a call back I'd appreciate it.
19 Thanks honey, bye.

20 CE Do you mind if I see the date on that? That's a new phone will that be able to
21 show me the date on it?

22 LT Yeah.

23 CE That's okay I'll look at it in a minute. I can... And you have not texted her back or
24 called her back?

25 LT No.

1 CE Okay. That's the only call you've received from her?

2 LT Yes.

3 CE You, you had said um, that you had asked them how they could still live in that
4 house. Can you tell me about that a little bit?

5 LT Yes um, and I said that because of me. I think I never want to be in this um, in
6 this situation.

7 CE Is it calling her?

8 LT No.

9 CE Okay says ah, I'm looking at the screen on a... what kind of phone is this?

10 LT It's a Chocolate.

11 CE A Chocolate?

12 LT Verizon.

13 CE LG Verizon, Cindy Anthony, 407-808-4731, 9:32 P.M., on January 13th, 2010.
14 Big capital letters, MISSED CALL. Thank you. So, she had.. you, you had said
15 that it almost appeared like ah, she felt that Caylee was still around?

16 LT Yeah she said, when I said, I don't know how you guys stay here I'm.. I'm
17 surprised that you guys are still here. I said, I don't know what I would do I don't
18 know if I could stay here. 'Cause as you look around there's all Caylee's pictures
19 and there's some of Casey and Lee and the things in the backyard you can see
20 out the window. And um, she said that her Caylee was here and her children
21 grew up here, was raised here. And this is where her family is and this is where
22 she wants to stays. And George said nothing.

23 CE Anything else that you can think of that we'd be interested in?

24 LT No.

25

1 SA Does, does ah, does George ever say much when you're with George and
2 Cindy? Or does Cindy always do the talking? It seems like.. who, who normally
3 answers and speaks up? Does George ever say much or...

4 LT No Cindy usually talks.

5 SA Okay so, Cindy usually does the talking with you're talking with 'em?

6 LT Yeah before all this came out I was, I didn't spend much time with Cindy. 'Cause
7 Cindy wasn't down at the table that much. I spent it with George and George
8 would talk you know.

9 SA Yeah.

10 CE How did... I'm sorry go ahead.

11 SA Did ah.. talking about the tape. I want to go back to the tape. Now you're sure
12 that they never said to you um, if the police are interested in tape or any tape that
13 we have. We'll be more then happy to bring whatever tape we have to them? To
14 help them find the truth?

15 LT No.

16 SA You're certain they never said that?

17 LT No.

18 SA And you're certain they never.. that they said that they'd never seen Roy Kronk
19 except on television?

20 LT Cindy said that. Yes.

21 SA Okay. Did Cindy ever or was there ever any talk of, because if you recall early
22 on there was a lot of talk about Zeniada Gonzales being the kidnapper. Did they
23 ever say to you that um, that they or the defense team or Mr. Conway or their
24 private investigators had ever found any connection between a Zeniada
25 Gonzales who is the baby sitter and Roy Kronk?

1 LT No.

2 SA Okay.

3 LT Huh-ah. (Negative)

4 CE So, there's no fresh leads, no new stuff that they mentioned while you were

5 there? No...

6 LT No.

7 CE No new suspect (Inaudible)...

8 LT No. Just that she had never seen or talked to Roy Kronk except TV.

9 SA Lots... lots been made over Texas EquuSearch and their records. Have you

10 followed that much?

11 LT (No verbal response.)

12 SA Um, and obviously you turned over what records you had from the Kid Finder

13 tent too us which was, that two page ah.. And you said that when we talked to

14 you before that you had shredded a bunch of records. You recall who told you to

15 shred those records?

16 LT They weren't records um, what you consider records.

17 SA Documents.

18 LT I just threw 'em away I didn't shred 'em. When...

19 SA I.. I thought when we talked before that, that.. well did you throw them.. well who

20 told you to get rid of 'em or ...

21 LT Well, nothing people would stop by the table...

22 SA Right.

23 LTtent whatever and they would say, um, especially to George. Everybody

24 stopped to see George.

25 SA Uh-huh. (Affirmative)

1 LT You know. And they would ask him is there anything we can do, how can we
2 help? And he'd say, well if you can give some of your time at the table, oh yeah
3 we can do that. Over half of 'em never did. But they put his ... put their name
4 and phone down and it would be on like maybe ...

5 SA Right.

6 LT ... a little scrap of paper. And he would give it to me or put a book..

7 SA Right.

8 LT ...the book. And I would bring it home and I'd type it on that paper. And...

9 SA And all those ..

10 LT I just...

11 SA all those pieces of papers and all those doc... where are they now?

12 LT Oh I threw 'em away.

13 SA Okay.

14 LT There was no sense to keep 'cause I typed on the paper.

15 SA But what, my question to you is they're gone, there's no way of getting 'em? Did,
16 did you throw them away on your own or did somebody tell you, we don't need
17 'em throw 'em away?

18 LT No I threw 'em away on my own. .

19 SA Okay. Alright. Did ah, you said that, that he suggested these people they come
20 back and help with the tent. Do you ever recall any of the, either George or
21 Cindy um, making the suggestion to these people that they come over ah, to the
22 search for Caylee and help with the search over ah... And I'm sure you're aware
23 that ah, that umm, EquuSearch was here and the did..

24 LT Yes.

25

1 SAsearches. Do you ever remember them making any suggestions to anybody
2 that they come with the search?
3 LT Okay I, I don't understand.
4 SA Did George, I know earlier you said that Cindy really was never around the tent.
5 LT Correct, she'd...
6 SAGeorge was.
7 LTstop down now and then, but she wouldn't stay.
8 SA Right. Okay.
9 LT Yes.
10 SA But George was there fairly often.
11 LT Correct.
12 SA Met with people, talk with 'em.
13 LT Right.
14 SA My question is, you ever recall George suggesting to people, well if you want to
15 help you can go over and help with the search? Did you ever hear those words
16 come out of his mouth?
17 LT No.
18 SA Okay.
19 LT In fact if people worked at EquuSearch they weren't allowed at the table.
20 SA Why is that?
21 LT I don't know.
22 SA Okay.
23 LT 'Cause they were, I guess.. I assumed that they were looking for a dead body.
24 SA Uh-huh. (Affirmative)
25

1 LT And we believed Caylee was alive and looking for Caylee.

2 SA Right.

3 CE I want to ratchet this thing down with the photograph when you get done John.

4 Before..

5 SA Go ahead.

6 CE The um, when discussing at the house on January 12th, was it?

7 LT Yes.

8 CE When you described the photograph the image that I'd shown you.

9 LT Yes.

10 CR To the Anthony's. How descriptive were you? Did they realize what picture it

11 was? 'Cause the media coverage and all at the time didn't realize that it was...

12 LT I just said a poster with black tape on it.

13 CE Okay.

14 LT That's all I said.

15 CE Did they, did they make that connection that it was the stuff that's on the media,

16 that it's the missing person's image of Caylee with tape stuck on it? Did they

17 make that or don't you know?

18 LT I don't know. I just said the poster. The regular poster which was the one that

19 was out there with the fliers and poster.

20 CE Did George say anything about the tape that he had brought to the tent that yeah

21 that's the tape or no that wasn't the tape?

22 LT No he never said one way or the other.

23 CE So, he let that topic go? He didn't... even though you told him we were curious

24 about the tape that he brought to the tent. He didn't discuss it any further?

25 LT No.

1 SA Hm.

2 CE So, he didn't say, well that's not the tape I brought?

3 LT No.

4 CE Or that is the tape I brought don't you remember?

5 LT No.

6 CE No further... Okay.

7 SA Um, do you recall during any of this time them ever making any comments about

8 anybody from EquuSearch coming to their house and talking with 'em at their

9 house? Or was there ever any discussion of that, they seem upset about the

10 people of EquuSearch...

11 LT I...

12 SA ... coming to their house? Or...

13 LT I know when Tim Miller, Miller first come to town.

14 SA Uh-huh. (Affirmative)

15 LT I think Tim was down there. 'Cause I think they called Tim in if I remember.

16 SA Yes they did call Tim in.

17 LT Okay.

18 SA Tim was here.. Tim Miller and EquuSearch was here at the Anthony's request.

19 LT Right. And then.. I guess they started looking like in swamps and woods and all

20 that there. But what I understand and that's when I guess the Anthony's got

21 upset 'cause they felt they were gonna be here looking... I don't know like at air

22 ports or malls or some place for Caylee. A live Caylee and...

23 SA Did they just think that with all the attention going on with it being in the national

24 news that somebody would just find Caylee walking around at the mall? I mean

25 is that, did they give you that impression?

1 LT Well, I think they, they had a lot of sightings. Like the.. I knew of one in Wal-
2 Mart.

3 SA Uh-huh. (Affirmative)

4 LT On Hoffner. One at the airport.

5 SA Right.

6 LT And then there was (Inaudible)... one in California or something I don't know
7 exactly where they all were. But I think they were hopeful that that was Caylee.

8 SA Right. Um, well lets get... But was there any discussion of them being upset
9 about the.. I know about the fact that maybe the EquuSearch wasn't searching
10 the way they wanted 'em to search. Was there.. ever say to you that they were
11 upset about something that happened at their house involving EquuSearch?

12 LT Ah, no just that Cindy got mad at Tim one day, told Tim to get out or something.

13 SA Okay. Did, did he.. she ever say why she told him to get out?

14 LT No.

15 SA Did ah, was there ever any discussion about ah, did she say during the time that
16 she got mad and told Tim to get out that ah, there'd been any ah, conversation
17 with ah, um, with Casey? Was Casey there when.. when she told 'em to get out?
18 When Cindy told Tim Miller to get out?

19 LT I don't know.

20 SA You don't know the answer to that?

21 LT I don't.

22 SA Okay. Alright. Did ah, do you remember who was representing the Anthony's
23 early in this case before Brad or...

24 Lt Yeah what's his name.. DeJame?

25


1 SA They ever tell you anything about him? Was there any, did they ever have any
