8 **Alright the date right now is December 2<sup>nd</sup>, 2008; the time right now is**  
9 **1109 hours. I'm Detective Melich with the Orange County Sheriff's**  
10 **Office reference Orange County case number 08-74777. Also present**  
11 **with me is uh Sergeant John Allen with the Orange County Sheriff's**  
12 **Office. We're located at uh 2500 West Colonial Drive. On the phone**  
13 **right now we had a Sean Krause from the Daily BS is that correct sir?**

14

15 **SK** That's correct.

16 **YM** Okay and you understand this is being recorded?

17 **SK** Pardon?

18 **YM** Do you understand this is being recorded?

19 **SK** Yes.

20 **YM** Do you have any objection to that?

21 **SK** No.

22 **YM** Okay. Mr. Krause I called you up um a short while ago cause I was  
23 reading a, an article that you posted, it's entitled "Father Krause;  
24 Cindy's Confessions Part II". And without going too much into the  
25 article, basically about conversations you had with Cindy reference  
her personal beliefs and what may have happened to her

1 granddaughter Caylee as well as some email correspondence back  
2 and forth between you two on uh, particularly about an Excel  
3 spreadsheet uh about here, Casey's friends and, and drug use. Are  
4 you familiar with that?

5 **SK** Correct.

6 **YM** Okay. In your own words and all I'm gonna ask for specifically what  
7 you spoke to Cindy about. Uh in your own words can you tell us how  
8 that conversation started and, and basically what it was about?

9 **SK** Well I mean... it's, it's, we talked in an array of things. Um which,  
10 which varied from uh her (inaudible) feelings on, on the case itself.  
11 Uh you know on, on her day to day life as well as um some things  
12 that she wanted me to do for her. Uh because she didn't uh want uh  
13 you know people to, to be scrutinized so she or rather herself be  
14 scrutinized so she had others do the, the nitty gritty work for her.

15 **JA** What kind of things did she want you to do?

16 **SK** Uh well I'll give you a for instance. Uh we, alright uh I, I interviewed  
17 uh Zenaida Gonzalez. Uh the uh fathom uh you know babysitter of  
18 course. Uh and you know we, we went through the Florida data base  
19 records and uncovered a lot of great stuff uh on Zenaida Gonzalez  
20 and, and proved her up to be a liar. Uh and you know unfortunately  
21 that worked for uh Casey's uh defense because....

22 **JA** Who proved, Zenaida to be a liar?

23 **SK** (Inaudible)

24 **JA** I'm sorry, proved Zenaida to be a liar or Cindy to be a liar? I'm not  
25 sure I'm following you.

**SK** Uh Zenaida Gonzalez.

1 **JA** Okay to be a liar. The, the Zenaida that is suing them now?  
2 **SK** Correct.  
3 **JA** Okay.  
4 **SK** Uh you now there's just a, there was some information about the fact  
5 that she claimed that uh you know that uh you know she didn't work  
6 and all the, and all this other stuff. Well come to find out you know  
7 she was, she's accepting social security benefits. Uh and it seems  
8 that uh the place she's actually working for, it seems to be  
9 underneath the books. So uh it's you know and you know so I shared  
10 that information with Cindy who uh passed it on to uh, uh Jose Baez  
11 and that kind of uh opened things up if you will.  
12 **YM** Right. What uh, so in, in, in, in regards to the article that you wrote  
13 today about her conversation about her daughter, tell me about that  
14 um that conversation specifically? When did that take place?  
15 **SK** Uh that was actually uh 3 weeks ago. Uh when I spoke with her she  
16 was uh, I believe it was 3, cause this is where, it was um it was  
17 around the same time that Leonard Padilla uh had came uh you know  
18 back uh to uh, uh Blanchard Park there to uh you know search for the  
19 remains for Caylee and you know she uh, you know she had my  
20 number built into she cell phone and you know she was crying and,  
21 and you know we got into the discussion of, of you know what she  
22 believed uh cause I had asked her you know I was you know and I  
23 told her I was like "You know I really strongly believe uh that, that uh  
24 you know your daughter uh you know murdered uh, uh Caylee" and  
25 she you know she contested it uh not just uh 3 weeks ago but you

1 know she had that same front for the last uh couple months that I've  
2 actually spoken with her.

3 **YM** Uh huh (Affirmative)

4 **SK** Um and, and when I spoke with her uh you know on the, on that  
5 particular day it was the first time that she agreed that she actually  
6 really believed that her daughter um you know actually did something  
7 to Caylee.

8 **YM** And....

9 **SK** She wouldn't, you know she wouldn't emphasize and, and I asked her  
10 for uh you know for clarification. Um but she say you know I, I, I  
11 really believe that, that my daughter uh actually uh you know did  
12 something with Caylee.

13 **YM** When you say...

14 **SK** And that kind of, that bothered me.

15 **YM** This, this was a, this was the same conversation when uh Padilla was  
16 in town at Blanchard right, 3 weeks ago?

17 **SK** Correct.

18 **YM** Okay. I'm looking at my calendar it looks like it was the week of the  
19 10<sup>th</sup> of uh November because Equusearch was in town that weekend  
20 prior. They were in town on the...

21 **JA** Right.

22 **YM** ...7<sup>th</sup>, 8<sup>th</sup>, 9<sup>th</sup>, and uh Padilla stayed through the 10<sup>th</sup>. He stayed  
23 almost through the, I think the 14<sup>th</sup> cause the shuttle went up on the  
24 13<sup>th</sup> or 14<sup>th</sup> so that, that's about the timeframe we're talking about?

25 **SK** Uh it, it, it fits around that timeframe because that was the same time  
that Cindy also had uh; she had a friend uh Dennis uh something. Uh

1 I don't remember his name uh he was there at Blanchard Park uh the  
2 cowboy guy. I, I don't know his name, his last name off the top of my  
3 head. Uh but you know she had some issues with Leonard and so uh  
4 that was a busy weekend.

5 **YM** Right. Um Dennis Millstead from Kid Finders, is that right? Is that the  
6 person?

7 **SK** No this was uh the, the, uh no not the kid finders guy, this is another  
8 guy. Um I'm trying to find his name for you.

9 **YM** Okay.

10 **SK** Uh because he, Cindy had given me his number and you know I  
11 spoke with him a couple of times and I'm like okay his doesn't make  
12 any sense. Why, why do you, you know why do you uh, you know  
13 and I asked him I'm like, "Well why do you care so much", he said  
14 "Well you know I, I, you know Cindy had asked me to come down  
15 here you know on her behalf and you know all I did was come up  
16 there for lies". And I'm like that doesn't; you know that doesn't make  
17 any sense.

18 **YM** Hum.

19 **SK** Uh and it was, and his name is Dennis Martin.

20 **YM** Martin?

21 **SK** Yeah Martin. M, M A R T I N.

22 **YM** And he was ....

23 **SK** That was on the 11<sup>th</sup> of November.

24 **YM** Okay.

25 **SK** Uh when that email was sent to me uh for that, for that uh, um for this  
individual so it, it was around, between the 11<sup>th</sup> and the 13<sup>th</sup>. Uh....

1 **JA** Was it sent; was it sent from Cindy's email account?  
2 **SK** (Inaudible)  
3 **JA** Was it sent from Cindy's yahoo email account?  
4 **SK** Yes.  
5 **JA** Okay.  
6 **YM** And uh just for clarification we spoke a little bit before the recording  
7 um I had asked that if any, if you could forward or do me a favor  
8 forwarding any emails that you may have had with uh the Anthony  
9 family regarding the Anthony family with, specifically with Cindy. If  
10 you could forward those to my work email, I sent you a, an email from  
11 my work email uh if you'd be so kind to do that.  
12 **SK** Sure I, I have no issues with that at all.  
13 **YM** Fantastic. Now back to the conversation. You said that there was a  
14 first time that she really didn't uh just ... I'm not really clear, did she  
15 actually tell you that she thought Casey harmed Caylee or you just  
16 thought Casey had something to do with her disappearance.  
17 **SK** No she, uh, uh the way that the, the exact wording and, and, and I'm  
18 gonna tell you the exact wording is that she said that she honestly  
19 believes that Casey had something to do uh with uh, uh Caylee. Now  
20 she didn't say disappearance or, or you know and when I asked her  
21 for whether or not uh she believed that um, you know that you know  
22 she had murdered Caylee uh she was quiet, she, she....  
23 **(Phone chirping)**  
24 **SK** ...she didn't say anything. Um you know I, I, when I asked her if she  
25 believed maybe it was one of Casey's friends you know she hung out  
with a lot of bad uh, uh individuals.

1 **YM** Uh huh (Affirmative)

2 **SK** Uh she remains silent uh and, and it was just, it was, all you could  
3 hear was crickets uh if you will in the background.

4 **YM** Right.

5 **SK** But she didn't mention anything else. Um but it was, it was the next  
6 day when he actually retracted her statement and you know and she  
7 in that, that kind of irked me as well because it's like you know you go  
8 from one extreme to the other you want sympathy. But then you  
9 retract your own statement and then you, you tell people "Well no, no,  
10 no you can't use that". Uh because I believe that my daughter, my  
11 granddaughter is still alive. Okay so...

12 **YM** Uh huh (Affirmative)

13 **SK** So you make no sense.

14 **YM** So the statement she wanted to retract was that she honestly  
15 believed Casey had something to do with Caylee but she never  
16 necessarily said that she thought uh she had something to do with  
17 Caylee's death.

18 **SK** No she, it was that uh she, uh the uh you know the uh the, the issue  
19 with her was you know like I said I, I, you know went back and forth  
20 with her, with her on the issue um and you know it was uh um you  
21 know and she wouldn't uh, uh comment any further.

22 **YM** Right.

23 **SK** You know uh, you know I and you know I, it, it just, it just kind of uh  
24 you know struck me as, as, as odd.

25 **YM** Right.

**SK** That she would make that statement.

1 **YM** Oh sure. I'm looking at uh, I'm looking at the article and the reason  
2 I'm, I'm asking about this is cause it says specifically, I'll quote it here,  
3 it says um, "I'll tell you what's interesting because I listen to her tell  
4 me how she feels that Casey had something to do with Caylee's  
5 death but she, but says she can't fathom those words." Did uh, did  
6 she talk to you....

7 **SK** Oh hon, honestly that, that, that, because (stuttering) I, I, you know I  
8 read into people.

9 **YM** Right.

10 **SK** And the thing is is that that's, that, you know even though that Cindy  
11 remained quiet you know I, you know the way I look at it is that uh  
12 that hit a nerve. That hit, that really, really hit a nerve.

13 **YM** Sure.

14 **SK** And she doesn't have to come out and, and, and flatly say it. You  
15 know I, I and I can sense uh you know when people are lying and I  
16 can sense when, when someone's telling the truth.

17 **YM** Okay.

18 **SK** And honestly I, I really felt that you know uh because if, if she had  
19 any issues with, with my approach on it she would have, she would  
20 have said no, you know that's not what I think, I, I, don't think that uh  
21 Casey was involved in my daughter's death she would have  
22 corrected me on that.

23 **YM** Sure so she....

24 **SK** All she did was, all she did was, was, was remain quiet.

25 **YM** So it's more what....

**SK** (Inaudible)

1 **YM** So it's what she didn't say rather than what she did. When you, when  
2 you asked here specifically you know whether she had something to  
3 do with Caylee's death her not answering that was basically her, you  
4 know her not denying that was basically her saying yeah I think so, is  
5 that pretty much, do I understand that?

6 **SK** Right.

7 **YM** Okay.

8 **SK** Right. I, I, and, and I, you know anybody remains quiet I, I, I look at  
9 that as an admission of guilt.

10 **YM** Okay. What about um, to continue on, I'm just using your, your article  
11 as a reference point about her admitting her daughter was a  
12 sociopath. Was that the same conversation, the same day or did that  
13 come later?

14 **SK** No that, (stuttering) you know like I said, we've had an array of, of, of  
15 topics cause you know she uh, you know she, cause I told her you  
16 know I, I, I read a lot of books, I've talked to a lot of psychologists um  
17 you know and, and you know they agree that there's a, you know that  
18 based on uh Casey Anthony's actions that you know she fits the, the  
19 sociopathic profile. And I shared that with uh Cindy and, and she  
20 agreed with me.

21 **YM** Uh huh (Affirmative)

22 **SK** Um and you know I, I actually went ahead and I told her, I was like  
23 you know the, there, there's a way that you have to, to kind of you  
24 know work at it uh, uh you know a sociopath works differently. Uh  
25 you know you can't confront a uh, um you know Casey head on and  
say well you know where's your daughter because she just doesn't

1 care. You know you, you're talking about somebody who you know  
2 spends 8 hours in a mirror beautifying herself uh you know when the  
3 average woman only spends about 2 hours in the mirror. You know  
4 it's all about her. So you know and that's unfortunately what you  
5 have to make it about. And then you know you kind of throw in a little  
6 bit with Caylee and you know along the way you kind of get the, the  
7 half truths which she does provide but it's like all jig sawed out and so  
8 it's like a puzzle piece that you gotta put together.

9 **JA** Did she ever talk to you about uh, she ever say anything or talk to  
10 you about um, um the lies Casey told them about working at  
11 Universal and just the entire you know she, did you ever have a  
12 conversation with her about Casey generally before this happened  
13 and why she thinks that....

14 **SK** Well I, I, I mentioned to her, alright uh cause the, the, uh I'm, I'm  
15 gonna tell you how we initially uh, actually first even, even uh got into  
16 talking because um you know there was, there was rumor that, that  
17 Casey worked for some escort service called Universal.

18 **JA** Okay.

19 **SK** And you know I, I and I mentioned that to her and, and you know she  
20 said that she knew nothing of it. Uh there was a website that uh had  
21 uh some uh I, I can't remember if it was a picture or if it was, if it  
22 remotely said her name. It just, just, it just struck me as odd, this was  
23 a, a, you know escorts uh, uh in the Orlando area. So I mentioned it  
24 uh in an article that I had to pull un, unfortunately because uh, uh,  
25 you know Mark NeJame and Cindy didn't like uh, uh the angle with it.  
Uh and uh that was the only time that I, I actually mentioned

1 Universal. Uh cause I was trying to put the parallels in between  
2 Universal and Universal uh, uh you know studios.

3 **JA** Yeah.

4 **SK** Actually it was called Universal Entertainment um and Universal  
5 Studios so yeah she did work for uh, uh a Universal but it wasn't  
6 Universal Studios.

7 **JA** Yeah but she also, I mean (stuttering), I guess did Cindy ever talk to  
8 you about Casey lying to them about saying she worked at Universal  
9 Studios while she was unemployed, while Casey was unemployed?  
10 Was there ever any conversation uh between you and Cindy about  
11 Casey's lies generally about things like that? Or, or lie...

12 **SK** Well yeah because uh she, uh she had said uh, I mean it's all the  
13 reciprocated stuff that she's told the media.

14 **JA** Right.

15 **SK** You know from uh George uh you know going through and, and  
16 contacting the uh, I believe it was the Sports Authority place, going  
17 there you know finding out that she didn't actually work there. Uh the  
18 fact that they actually uh, she said that they contacted Universal  
19 Studios themselves after you guys uh you know had uh nailed her uh  
20 in the interview there and caught her in her own lie there. Uh they  
21 said that you know that she had contacted Universal Studios herself  
22 to find out she did work there as well uh you know so, you know it just  
23 seemed like she was kind of uh you know going back and forth uh  
24 based on your guy's information uh and, and we're confirming things  
25 as it is.

1 **JA** What, have, have you had any conversation with her about the  
2 spreadsheet uh this Excel spreadsheet with uh all the people's  
3 names in it that uh, uh that, that was sent to Dominic the investigator  
4 for um Mr. Baez?

5 **SK** No I, I, you know I uh, I, I have not uh had any conversation with  
6 regards to that.

7 **JA** With, with Cindy about that.

8 **SK** Correct.

9 **JA** Okay. Um....

10 **YM** Let me go um, move on to the emails here real quick. Tell me about  
11 these emails uh as, as far as the Excel spreadsheet and  
12 communication. It says here uh basically she, I guess you had email  
13 correspondence with Cindy about certain emails. Uh she's claiming  
14 that uh the emails were released to the news unknown to her but you  
15 were able to determine that um it came from a, a IP address that  
16 comes back to a family member. Uh if you can kind of walk me  
17 through that.

18 **SK** Well on, on, you know on Friday I, I, when I closed the uh the article  
19 itself I, I wanted to, to just end you know communication with Cindy  
20 um and on Saturday I got, uh it was 6 emails um from Cindy's email  
21 account, her yahoo account uh where she says "Oh hey you know I  
22 got this big scoop for you" you know "It's very uh big uh, uh  
23 something that you can use on Monday", I'm like "Okay". So I follow  
24 up, I send a reply and then I get email back that says uh "Well I heard  
25 you've been releasing all of my emails". Okay so I, I reply to that uh  
and then you know "Why". And then I, I, I gave her my answer and

1 the answer was because the public deserves the, uh the reason you  
2 know to, to know. You know uh, uh of what uh, what has been said  
3 and what's been transpired. Um and you know you put yourself into  
4 that light, the people have a right to know. So, and then it, it, it just  
5 keeps going back and forth and then the last one that I had gotten  
6 was this uh "Is there a number that I can reach you". And that kinds  
7 struck me as odd because it's like well Cindy you have my number  
8 built to your cell phone.

9 **YM** Huh.

10 **JA** Yeah.

11 **SK** But I'll give it to you any how so I, I, I gave them my, my personal cell  
12 phone number um and you know I, I you know left it as such. Uh it  
13 wasn't until 3 hours later on Saturday uh that Cindy uh, uh texted me  
14 and, and asked me uh you now uh, uh what was going on.

15 **YM** (Inaudible background talking)

16 **SK** Um you know what uh, uh, the emails and such and I told her I was  
17 like I, I don't, I don't know what's going on, you sent me these emails  
18 and she goes "No I didn't".

19 **JA** What emails were they?

20 **SK** you know?

21 **JA** What emails were they that she said that she did, what emails did you  
22 get from her that she said she did not send?

23 **SK** Uh that, that was uh like I said uh, uh the ones that uh that stated uh,  
24 now it started with uh, uh actually it started with "I give up". And the it,  
25 it, it, it worked its way to you know I have a big story for you. You  
know uh this is something that you can use for Monday, I'm like,

1 "Okay" and then I go on and on and then so all 6 of those emails  
2 she's contested that uh she didn't send. And the, the IP address uh,  
3 uh it differs from uh, from the Anthony uh, uh IP address as it is. Uh  
4 this one uh it comes form Embark uh cooperation or whatever that it  
5 is. Uh Cindy's uh, Cindy has Time Warner cable.

6 **JA** Right.

7 **SK** Uh so obviously the email or the IP uh, uh addresses uh differs than  
8 uh, um you know what I'm used to.

9 **JA** Right. What, what, the, the content of those emails, what were they,  
10 the scoop emails that she's claiming she didn't send, what were they?  
11 What did, what, what was in those emails that, that would have been  
12 of, of great interest?

13 **SK** Well she, she, she sent a, a, a um you know it was the same thing  
14 that, that uh, uh, uh you know the, the, the spread, she sent a, some  
15 spreadsheet document about uh some uh just, some drug angle that,  
16 that uh, uh, um they believe uh you know Casey because the, the, in  
17 the, in the spreadsheet or something like that, it said something  
18 about, along the lines that you know Casey was doing drugs and, and  
19 you know I, I honestly and I, I've shared this with a few others that I  
20 think that this was uh some angle that they were trying to uh to throw  
21 out there to the media uh as a way to um you know cast some, some  
22 doubt that uh Casey uh was uh, a uh murder itself.

23 **YM** Were these emails sent directly to you or were they CC'd to you? In  
24 other words were you the only recipient?

25 **SK** No. They were, they were sent directly to me.

**YM** Okay.

1 **JA** And you can forward them to us?  
2 **SK** Sure.  
3 **JA** Okay.  
4 **YM** That, that would be great.  
5 **SK** I, I, I have nothing to hide so uh, uh, you know I, I just, you know I,  
6 like I said I, I, it just kind of struck me as odd uh with all these emails  
7 and then you know and then to have somebody flatly deny that, that  
8 you know you, you, you know sent these emails. It just, it doesn't  
9 make any sense.  
10 **JA** Uh huh (Affirmative)  
11 **YM** How um, how did you, how did you find out about the IP addresses.  
12 You mentioned that earlier before we went on tape about uh I guess  
13 your being somewhat familiar with IP addresses and knowing how to,  
14 I guess how to figure out ....  
15 **SK** Uh you know I, I, I deal with a lot of people who obviously hate me for  
16 you know, for what I do, you know whatever. People, people have  
17 objected opinions of everybody so you know I, you know I, I use uh  
18 websites, I use programs that uh, uh, you know can, can trace an IP  
19 address uh right down to the origin of its location.  
20 **YM** Uh huh (Affirmative)  
21 **SK** I have a friend of mine that actually uh, uh trace the IP address uh  
22 directly to an address and I also have a, a local uh, uh police officer  
23 who uh locally here who also helps out in the event that, obviously  
24 that I, I don't have all my, my ducks in a row. Uh you know who can  
25 **JA** That email that (stuttering), did those emails originate in Mount Dora?

1 **SK** No uh the uh the first email address uh, uh came from uh, um Ocala  
2 and then the other ones came from Winter Park.  
3 **JA** Ocala and Winter Park.  
4 **SK** Yeah.  
5 **JA** Okay.  
6 **YM** Is it Ocala or Ocoee? Cause there's no Ocola.  
7 **SK** (Inaudible, stuttering) you gotta understand, I'm sorry for the  
8 pronunciation.  
9 **YM** No that's fine.  
10 **SK** Uh it's O, O, what, Ocola or however you pronounce that city. Uh  
11 that's a tongue twister for you.  
12 **YM** That's okay. (Stuttering), I'm looking at in on the uh on the side I think  
13 its written O C O L A, there's not Ocola, there's Ocoee....  
14 **JA** And there's Ocala.  
15 **YM** And there's Ocala. But it's spelled wrong so I don't....  
16 **SK** (Inaudible), yeah uh, um the O, the uh Ocala.  
17 **JA** Yeah.  
18 **YM** Okay. And you said you found that out uh, you found that one of the  
19 emails came from that area or that IP address.  
20 **SK** Right.  
21 **YM** But um any way to find out what address it came to with all your  
22 resources or...  
23 **SK** Uh that's actually what I'm working on right now.  
24 **YM** Okay.  
25 **SK** Um you know I, I'm working on uh, uh, on, on specifics uh for an  
address. Uh and then it, it, sometimes it works sometimes it doesn't.

1 Um you know and, you know I mean based on, on looking through  
2 you know cause uh people are like well how, how do you have  
3 access to uh Cindy's uh, uh family email. Well you know you, you  
4 gain access. You know you get I guess entrusted into the, into the uh  
5 the, the um what I like to call the lion king circle of trust, whatever.  
6 Uh so you know they, you know you get uh forwarded all these jokes.  
7 You know I was uh, uh given um, you know Cindy had send me some  
8 uh some stupid jokes you know the, that everybody sends you  
9 whatever. Uh and then you get all those email addresses that she  
10 sends you know that you know are listed that are CC you know to all  
11 of her friends and family. And you know it's great, you know you  
12 have all the access information in front of you.

13 **YM** So through, through these emails you have you, you pretty much  
14 have a pretty good data bank on whose IP is who, whether it be  
15 George or Cindy's or Lee's or, or the mother or maybe even the  
16 brother and all that right?

17 **SK** Right uh and then you know when, and like I said what I did was I  
18 sent a, a, a uh a test or a dummy email if you will from uh, from one  
19 of my own personal accounts uh not related to you know what I do.

20 **YM** Right.

21 **SK** And I just, I simply enclosed it as test and uh Cindy's mother had  
22 gotten back to me and says "Well who are you". You know and, and  
23 I, I, like I said I only did that cause I, I wanted to nab the IP address.

24 **YM** Sure.

25 **SK** And, and I matched it accordingly. Because that same IP address  
also was the same IP address that all, that uh went to my website

1 (stuttering) so you know everything gets recorded so it's great you  
2 know.

3 **YM** Huh. Would uh, would you be able to include that in an email to me  
4 as far as what you have on IP addresses and the names that they  
5 come back to as far as your investigation?

6 **SK** Yeah. Uh I mean you; you'll have to give me some time....

7 **YM** No that's cool.

8 **SK** ...to, to sort through.

9 **YM** That's quite alright.

10 **SK** I, I, I have, I have, I have no issues with that.

11 **YM** That's quite alright. One other thing I wanted to mention is again I'm  
12 just, I'm using your uh report as a template here or your, your article  
13 as a template, mentions 2 videos of Caylee with Casey that the public  
14 hasn't seen. Um....

15 **SK** Yes uh, um I, I ran a um, uh out of respect for Cindy, Cindy had  
16 asked me to pull, uh I owned, well I still own it. Um I own uh Caylee  
17 Memorial dot com. It was a memorial website uh that uh you know it  
18 was just a, a place for people to reflect and leave their, their thoughts  
19 and prayers for uh Caylee Marie Anthony.

20 **YM** Right.

21 **SK** Um Cindy didn't obviously like that you know uh and, and I pulled it  
22 out of respect for her. Um but through the course, while the site was  
23 in operation you know there was um, it, I mean the site was popular,  
24 it was like 20 million people, uh people loved the site. It was, it was  
25 you know it was uh, it was uh, a, a cheerful moment for most. Um but  
it, it, I was sent uh these uh, these two videos um and uh the videos

1 were, I, you know I, I don't know, like I said I get a lot of uh crap that's  
2 sent to me uh, anonymously uh and that's where, how the email  
3 address came through as anonymous. Uh and it said you know I, I  
4 respect what you're doing you know, you know these, these videos  
5 uh you know mean, you know have some importance to me. Um you  
6 know and, and if you could uh, uh share them and, and put them onto  
7 your, onto your website. Well that's what I was going to do but  
8 because of high bandwidth cost and stuff I just, I, I couldn't do that  
9 and, and it, it, it upset me but I, I, I couldn't do it. Um but when Cindy  
10 found out that I actually had gotten uh, uh, uh hold of these videos  
11 um you know she wanted these videos and I said you know what I'm,  
12 I'm, I'm not at liberty to give you these videos.

13 **YM** How did she find out about them?

14 **SK** (Inaudible)

15 **YM** I'm sorry how did she find out about them?

16 **SK** Well because on, on, on the, on the website you know I, I specifically,  
17 cause I told people, I'm like you know if, you know if you, you know if,  
18 if, you know if, if, you know if you could help out in any way you know  
19 for the bandwidth cost you know we would be able to put these  
20 videos out there for people so that people can have a uh you know a  
21 place to, to mourn and, and, and respect uh, you know the 3 year old  
22 Caylee.

23 **YM** Got cha'.

24 **SK** Uh so she had gotten it off the website and, and she's had been  
25 hunting me down every since and I, you know I, I told her you know  
and she, you know she went as far as to, to try to say that uh, uh she

1 was gonna provide some legal action against me or whatever. And I  
2 just said "You know what, I'll just delete uh the videos because you  
3 know what I, I don't, I don't wanna get myself involved with you", um  
4 you know and there, there weren't even anything of, of, anything of  
5 the utmost importance.

6 **YM** Uh huh (Affirmative)

7 **SK** They were just uh you know I, I, you know and it's that same thing I  
8 told uh, uh, uh Cindy that the videos, I don't know what they said they  
9 were, if they were just uh it, it, it seemed to me it was taken uh with a  
10 friends camcorder, who that friend is I, I don't know. Uh but it was  
11 just, you know Casey and, and Caylee, they were sharing a laugh  
12 and I thought you know that would be nice to put up. Uh....

13 **YM** Did, do you know when those were sent to you? Do you remember?

14 **SK** Uh those were sent uh (stuttering), I believe it was in uh the end of  
15 August or maybe early September.

16 **YM** And when did the site, when did you actually pull the site do you  
17 remember, approximately?

18 **SK** Uh the site, uh the, the site was pulled on the 1<sup>st</sup> of, of October.

19 **YM** Okay.

20 **JA** And she already, did you send her the uh the videos or do you still  
21 have them?

22 **SK** No.

23 **JA** She doesn't...

24 **SK** No I, I, because I, I mean, cause she still keeps asking me for them  
25 and I'm like....

**JA** Did she indicate, did she indicate whether she....

1 **SK** (Inaudible) videos.

2 **JA** Right. Did she ever indicate she wanted to sell then or what she was  
3 gonna do with them?

4 **SK** Uh she has said something about that uh because she had gotten  
5 pissed off because of the fact that, that, you know people were  
6 sending pictures of Caylee. Um and she's like "Well it's not your right  
7 to, to hold those photos". I'm like, "Well for one Cindy uh those  
8 photos are public domain". And somebody sent me something then I  
9 have a right to put those up, you don't have any clout over, you know  
10 I'm not making money off of, off these uh, off these pictures or the  
11 website itself. You know it's just something for people to reflect.

12 **JA** But they might be worth...

13 **SK** (Inaudible)

14 **JA** ...they might be worth money to somebody else.

15 **SK** Well right but you know from what I had gathered was that she uh  
16 wanted to put together some video package of, of, of Caylee and at  
17 some point wants to, to release uh some videos of Caylee for profit. I  
18 don't know if, if it to pay for uh, uh Casey's defense fund, I, I, I don't  
19 know.

20 **JA** Yeah. Did she specific....

21 **SK** But that's what, that....

22 **YM** Did she specifically tell you that?

23 **SK** Yeah because uh, uh you know she said that uh I have on right in, in,  
24 in, in, the ownership of these videos. And I and that's what I told her,  
25 I'm like, "Well who the hell are you to sit there and tell me you know  
uh, uh, what I can and can't own". "Somebody sent these to me

1 anonymously". It's not my fault that the uh, uh that you know  
2 somebody you know thought, you know I think they were thinking in a  
3 positive light um but you don't have a, a um, you don't have a, you  
4 know you, I'm not giving you these videos.

5 **YM** How uh....

6 **SK** And uh the....

7 **YM** I'm sorry, how big are, how big are the video files? Are they, are they  
8 immense or are they just short clips?

9 **SK** Uh they, they, they were uh, uh they were the, the, the two movie files  
10 itself they were .avi and, and they were 5 minutes a piece.

11 **JA** Oh geez...

12 **YM** Okay so that's uh how many megabytes to you think that would be, in  
13 other words is, is there something that you think you could email to  
14 me? So maybe I....

15 **SK** Like I said I, I don't, I don't, I don't own the videos any more I, I  
16 deleted them on, on, you know on, for one I deleted them on the  
17 request of Cindy because you know I, I don't, and the thing is, is that  
18 I, I, I don't, you know I, I am not uh, uh in the position like most other  
19 um media networks you know. The thing is, is when somebody says  
20 well you know I'm gonna sue you and I'm gonna do this against you  
21 and all this other crap....

22 **YM** Uh huh (Affirmative)

23 **SK** ...no I'm just, I'm, I'm gonna play nice.

24 **YM/JA** (Inaudible)

25 **SK** No I'm not uh, uh I don't wanna be uh sued, I don't wanna be you  
know whatever, I'm not in that position. So I, I did the uh delete um

1 you know off of uh you know everything else and I, I, you know I  
2 ended it and you know I, I feel bad for doing it....

3 **YM** Do you, do you....

4 **SK** ... you know because....

5 **YM** ...do you know if copies of those exist and the reason I ask is that not  
6 knowing when they were taken, if they were taken before or after the,  
7 the child went missing it might help us in, in, it would, we, we could do  
8 a lot of magical things with videos.

9 **SK** (Inaudible). There was no, that was not time stamp on, on uh those  
10 videos.

11 **YM** Right.

12 **SK** Um and, and so it's, it's really hard to, to be able to determine um you  
13 now to me it, it actually looks like it was, it was just a younger uh  
14 Caylee uh along the likes of like when she was like one, maybe one  
15 and a half.

16 **YM** Right.

17 **SK** Cause she you know um cause she was still in like a, like a baby car  
18 seat or whatever.

19 **YM** Right.

20 **SK** What, whatever that um that kids use uh like a swing if you will. Um  
21 and, and so that was you know and that's why I, you know and I look  
22 back and that's why I said it, it didn't really feel relevant because you  
23 know uh Caylee was not uh, uh you know in uh a swing of sorts.

24 **YM** Right.

25 **SK** Uh you know she was very talkative uh to a certain point I guess.

**YM** So....

1 **SK** Uh based on the videos and stuff so that's why I felt that it was, it  
2 wasn't really relevant to uh to the case itself.

3 **YM** So in the article it says you have two videos, you no longer have  
4 them you deleted them? Is that correct?

5 **SK** (Stuttering) as of uh, uh you know uh the uh over on the uh, uh  
6 weekend there.

7 **YM** Okay. Well hey if, if, if by any chance you um, you're able to find out  
8 uh that those videos exist elsewhere would you, would you be so kind  
9 as to let me know cause I'd love to see them.

10 **SK** Yeah I, I, if, if you know I, I, you know the thing that I, like I said I  
11 mean uh, you know I mean I could, I mean almost the same as how  
12 you guys can do it. You know I can actually go through and, and try  
13 to find the videos uh....

14 **YM** Oh that would be great.

15 **JA** Yeah.

16 **YM** Yeah that, that would be great if it's something that you're able to do  
17 we, we'd, we'd appreciate that.

18 **JA** Did, did you ever, did you ever, did you have any conversation with  
19 uh with uh, uh Mr. Baez's investigator, Dominic?

20 **SK** Uh no.

21 **JA** Okay.

22 **SK** No.

23 **JA** How about with Mr. Baez? Jose Baez.

24 **SK** Uh I, I'd spoken to, I, I had spoken to his secretary...

25 **JA** Okay.

1 **SK** ...and that was uh you know, that was just passing information along  
2 uh on the Zenaida Gonzalez uh case itself.

3 **JA** Okay. But you never had conversation with, with Baez himself or with  
4 Dominic?

5 **SK** No.

6 **JA** Okay.

7 **SK** Cause uh, uh, uh Baez's secretary said that uh, uh, uh Jose Baez  
8 does not wanna waste his time with me.

9 **JA** (Laughter), okay.

10 **YM** (Laughter)

11 **JA** Well...

12 **SK** So I said okay well you know he...

13 **JA** His loss.

14 **SK** You know he can go, yeah he can go somewhere.

15 **JA** Uh huh (Affirmative)

16 **SK** And, and I left it at that.

17 **JA** Alright.

18 **YM** Is um, is there anything else about communications with, with Cindy  
19 or have you had any communications with anyone like George or Lee  
20 or even Casey about this, while she was out? Did they... did they  
21 ever write to you or call you or kinda get you to....

22 **SK** (Inaudible) that they, I, I've never spoken with uh, uh, with George.  
23 Uh you know George uh; uh he was always in the background. Um  
24 the only time that I've ever heard George uh I don't know there was  
25 some interview with some guy that uh, uh Cindy uh some guy name  
William Murtaugh uh who I guess George was supposed to I guess

1 going to go have an interview with and I guess, I heard Cindy yelling  
2 in the background, she goes "Well do you have an interview with  
3 Murt" and he's like, "Who the hell is Murt"

4 **YM** (Laughter)

5 **SK** (Inaudible) and that's the only time that I, I've, I've ever uh heard  
6 George. Uh as far as Lee goes uh you know on my own personal uh  
7 You tube uh, uh channel uh I did a, a, a video it was called uh, uh,  
8 Remember Caylee Anthony. And uh the, it was odd because this  
9 individual claims to be a member of the Anthony family. And uh you  
10 know you going back and forth, back and forth and basically the uh  
11 I'm gonna, I'm gonna share you his name here in a second.

12 **YM** Sure.

13 **SK** Um but he fisticuffs with me on, on you know, "Oh you know you  
14 shouldn't uh, uh put this video up" "Uh maybe, you know maybe you  
15 have something to do with this murder".

16 **JA** Huh, sure.

17 **SK** I go whatever.

18 **YM** Huh.

19 **SK** I'm like you know you make no sense. And when I find out that it's  
20 Lee uh you know sending these uh, these, these uh, these comments  
21 on, on this video I'm like you know what a, what an ass.

22 **YM** (Laughter)

23 **JA** Yeah.

24 **SK** (Stuttering) and that's what I sent him, I sent him a personal message  
25 on You tube, I'm like you know you really are an ass. You know I, I,  
this video is, is, is suppose to meant for you know people to, to uh, uh

1 have a reflection and you wanna sit there and, and belittle uh you  
2 know people who actually care.

3 **YM** Huh

4 **JA** (Inaudible)

5 **SK** You know that kind of like really struck me as odd. And that's why  
6 the video is actually so popular is because uh you know people were  
7 able to tie uh Lee uh You Tube uh you know into uh, uh his  
8 comments that he left.

9 **JA** Yeah.

10 **YM** Which uh, is, is there a, how hard, in order for me to see this video on  
11 You tube how would I, how would I go about it so I can see what  
12 you're referring to?

13 **SK** Uh if you go to uh....

14 **YM** Is there a name of the video?

15 **SK** Uh it's, well uh, uh if you go to my, my personal You tube channel is  
16 You Tube dot com slash user uh slash um the first 3 letters are, are  
17 all big so it's S M K and then the rest is all lower case so it should  
18 read S M uh Krause. Uh like it, the S M K is, is capitalized, the rest is  
19 all lower case.

20 **YM** Okay.

21 **JA** Yelp.

22 **YM** Uh what about the, the comment you made here about the water  
23 treatment plant, cell phone tower pings and all that, where are you  
24 getting that from?

25 **SK** Well you know I, I, I, I, I know a lot of people that, that uh looked  
through. Uh, uh obviously you know we, I cared about the case uh

1 you know and in looking through uh you know there was um a lot of  
2 activity uh in, in Blanchard Park. But then there was also activity in  
3 the water treatment, the, the, this water treatment facility.

4 **YM** Gotcha.

5 **SK** Uh it just kind of struck me as odd looking at these, at these cell uh,  
6 uh the cell phone ping data.

7 **YM** Okay so it's not....

8 **SK** I asked uh, uh Cindy, I asked Cindy myself I'm like you know what the  
9 hell's out there uh cause you know obviously I don't live in Orlando.  
10 Um you know and (coughing), excuse me, um you know I, I, I, I uh,  
11 uh, I use Google earth, it's a great program uh you know I have all  
12 the key features, all the key locations uh like your office.

13 **YM** Uh huh (Affirmative)

14 **SK** Um Jose Baez's office, the Anthony home, all the cell phone uh, uh  
15 pings towers that are actually in the neighborhood uh and so you  
16 know and, and looking through you know you did the (stuttering),  
17 latitude, longitude coordinates uh so that worked very well. Uh and  
18 uh so you know I, I, I just simply looked and, and you know it just  
19 kinda struck me as odd. You know and then I remember Local 6 uh  
20 you know having, having an article um you know I don't remember  
21 exactly when I, I, I believe it would be August uh maybe September  
22 that they found some household uh, uh chemical cleaning bottles uh  
23 in that area. And I'm like okay this is kind of odd. Uh and then they  
24 had uh I don't know some uh, the fake physics, uh Gail St John  
25 and....

**YM** Right.

1 **JA** Uh huh (Affirmative)  
2 **SK** And, and uh I don't know the SOS Team there. Um you know they  
3 went down and said that the quote unquote, searched the area. Well  
4 and then I find out that no the area wasn't actually searched  
5 thoroughly.  
6 **JA** Uh huh (Affirmative)  
7 **SK** Um so you know and that's, you know and that's all, it, it's just, you  
8 know it, it, it's something different you know and, and you know it just  
9 kind of struck me as odd.  
10 **YM** Right.  
11 **SK** Now why would somebody leave uh a bleach bottle um you know in,  
12 in you know all these household cleaning bottle, this doesn't make  
13 any sense.  
14 **YM** Now let me ask you, did you ever talk to Cindy about that hair brush?  
15 About uh, remember she....  
16 **SK** Uh yeah actually I did uh, uh cause that, that, that was another thing  
17 uh cause I, you know she uh, you know the thing with her is, is that  
18 she's , she's very um, uh, uh how would, how would I put it, she's  
19 very reserved. She doesn't wanna uh, uh, cause she knows, cause  
20 she, you know she's told me numerous times before that like her, her  
21 phone was being tapped and stuff so she has to be careful of what  
22 she said. I'm like okay um you know and, and she gives, she just  
23 gives the same uh BS uh, uh excuse you know that uh, you know that  
24 she didn't uh, uh try to deceive um you know the Orlando County  
25 Sheriff's Department. That you know she uh you know took the, the  
hair brush that uh you know the, the one hair brush and that she

1 provided that to you guys and she says you know she held on to the  
2 other one. She said that she didn't realize that she was supposed to  
3 give up the other one.

4 **JA** (Laughter)

5 **SK** So I'm like you know that doesn't make any sense.

6 **JA** (Laughter)

7 **SK** I'm like....

8 **JA** Yeah it does.

9 **SK** ...you know if you had two hair brushes you know why didn't she just  
10 give them uh, uh both.

11 **YM** Right.

12 **SK** You have one, you have one that has uh one strand of uh, uh DNA  
13 and, and maybe uh they weren't able to successfully uh pull, maybe  
14 extract uh, uh the uh DNA from Caylee's hair follicles. Uh with the  
15 other hair brush you would have been able to. You know so you  
16 know and I don't know, she just gives some, some crap excuse. You  
17 know "Well that's not", you know um you know I, I didn't think of it that  
18 way you know and, and so you know we left it at that.

19 **YM** Right. Okay so she never, never added anything to that, to what  
20 she's told everyone else, it was just an oversight on her part I guess.

21 **SK** Right.

22 **YM** Huh. Is um, is there anything else about Cindy, about the  
23 conversations you have that are, that are I guess right now are  
24 sticking out in your mind, that's something we should know about.  
25 Anything else that I haven't asked you about perhaps?

1 **SK** Well see... wha... see what's strikes me as odd is that I, now, now  
2 and I'm just gonna share this with you guys is that uh you know they  
3 had gone on uh, uh Todd Black uh who as Jose Baez's spokes  
4 person.  
5 **YM** Uh huh (Affirmative)  
6 **SK** Um now I, I actually, it's weird uh I, I've never spoken to this guy in  
7 my life before.  
8 **YM** (Inaudible)  
9 **SK** Uh he actually contacted me because I did a, an article on him  
10 because there was somebody that was trying to compare him to  
11 some Gil Cabot or whatever.  
12 **YM** Yeah I read that. (Coughing)  
13 **SK** You know he actually contacted me and, and you know we spoke for  
14 I don't know it was about an hour at least.  
15 **YM** Uh huh (Affirmative)  
16 **SK** Um you know and, and he goes into uh his theory on the fact that the  
17 FBI had screwed up on, on the tests, that uh they didn't actually uh  
18 um, do a thorough analysis um into the uh, uh you know with the, uh  
19 the chloroform test itself. Uh that they have somebody that, that is  
20 actually on record that says that the, that the, that the test were  
21 duped and I'm like I don't, I don't buy it. You know I, I think that...  
22 **JA** Did, did he ever...  
23 **YM** The FBI....  
24 **JA** Did he ever tell you that he was Gil Cabot or that he wasn't Gil  
25 Cabot? Did he ever, was there ever any discussion between you and  
uh him as to his true identity?

1 **SK** Yeah why his, uh the, the way that uh he, he states himself is that his  
2 name is Todd Black.

3 **JA** So he denied being Gil Cabot?

4 **SK** That uh this Gil Cabot guy lives in London England or something like  
5 that.

6 **JA** (Laughter). So he denied being Gil Cabot?

7 **SK** Correct.

8 **JA** Okay

9 **YM** Let me ask, let me ask you a personal opinion if you don't mind, if you  
10 don't wanna answer this, I understand that. Do you think Todd Black  
11 actually exist? Is, is he a person named Todd Black or do you think  
12 it's uh, an alias for someone else?

13 **SK** Well you know the man lives through secrecy; I mean uh you're  
14 talking about a guy who uh has to keep cloaking his cell phone.

15 **YM** Uh huh (Affirmative)

16 **SK** You know and them I'm like, you know and I'm listening to this guy  
17 and he, you know to me it, it makes me laugh because he, he kind of,  
18 he puts, kind of puts himself out there as like double oh seven. You  
19 know like he's, you know like he's got a license to thrill and I'm like  
20 you're not really that special.

21 **YM** He's...

22 **JA** You, you ever met a PR person that didn't want you to know who they  
23 are?

24 **SK** Yeah cause I, I, I ....

25 **JA** (Laughter)

1 **SK** He has all the secrecy and then he's like, "Well I can't tell you where  
2 I'm at but I'm in Chicago". Okay.

3 **YM** (Laughter)

4 **SK** You just told me where you're at.

5 **YM** (Laughter)

6 **JA** Yeah.

7 **SK** Make up your damn mind uh, uh you know and you know and so I, I,  
8 you know I, I told uh Cindy the same thing that, that Todd told me.  
9 You know uh you know and you know and, and it just kinda struck me  
10 as odd, I'm like you know you got this guy who uh, uh is off the case  
11 us with Jose. And if that's the angle that they're gonna try to present  
12 you know to try to say that the, that the FBI who you know I greatly  
13 respect, I think that do a, a great and thorough job, I don't think  
14 anybody's gonna lie. Um you know but if that's the, the defense  
15 strategy that uh, uh that they're going to use that the uh, the FBI uh  
16 had some people that uh were duping all those test. Well that's just  
17 crap.

18 **YM** uh-huh.

19 **JA** Yeah.

20 **SK** You know and, and you know maybe somebody would believe in that,  
21 that uh, uh BS line that uh you know he offered but...  
(Coughing)

22 **YM** Well let me ask....

23 **SK** ...(inaudible), I, I ....

24 **YM** (Throat cleared) let me ask another question. Besides me and, and  
25 John Allen have you talked to any other law enforcement? You said

1           you were gonna forward emails to the FBI, is it just FBI in general, do  
2           you have a contact there you were gonna forward them to?  
3 **SK**    Uh just the FBI in general. Just the FBI in general.  
4 **YM**    Can...  
5 **SK**    Uh, uh you know the, the Tampa Bay, nah cause that's the, the one  
6           that usually covers....  
7 **YM**    Right.  
8 **SK**    ...uh you know all of the....  
9 **JA**    We, we actually have an FBI agent....  
10 **SK**    You know I, I ...  
11 **JA**    ...assigned.  
12 **SK**    I mean I do have uh, uh you know obviously I, I, I, I can't get in  
13           contact with uh the, the main FBI guy whose handling the case, Nick  
14           Savage.  
15 **YM**    Right.  
16 **SK**    Uh...  
17 **YM**    Now I, I prefer it, if, if you do send it to the FBI please send it to Nick  
18           Savage and not uh a general mailbox only because....  
19 **JA**    Yeah.  
20 **YM**    ...you know obviously with, and the more information that gets spread  
21           around the greater chance is that somebody's gonna you know uh  
22           you know release it to someone or if someone not involved in the  
23           case gets an email they might look at it and go "Ow this is pretty  
24           good", I know...  
25 **JA**    If you send it to us we'll share it with Nick. Nick's, Nick's got keyed to  
          access over here and he's over here week, on a weekly basis.

1 **SK** Well maybe that's what I'll do is, is that and, and I'll forward to you  
2 guys and then you guys can forward it to uh Nick Savage.  
3 **JA** Perfect.  
4 **YM** That'll, that'll be perfect.  
5 **SK** You know so that way that there's no uh, um you know there's not  
6 back doors, no you know crap there's just....  
7 **JA** Right.  
8 **SK** ...you know straight forward you know and, and everybody's good at  
9 all levels.  
10 **JA** Okay.  
11 **YM** Um where are you based out of out of curiosity?  
12 **SK** Uh I actually live in uh the Western New York area.  
13 **JA** Okay.  
14 **YM** Oh okay.  
15 **SK** I live in uh, uh Buf, in the Buffalo New York area.  
16 **YM** Oh so it's, it's definitely cold up there right now.  
17 **JA** (Laughter)  
18 **SK** Yeah it, it definitely is uh it, it, it's, it's uh you know I, I can't even wear  
19 shorts unfortunately like you guys can.  
20 **JA** Right.  
21 **YM** Um....  
22 **JA** Alright.  
23 **YM** Uh is there a mailing address I could use. Uh like I said I, you don't  
24 wanna give your personal address that's fine uh given your  
25 profession. Is there a mailing address I could use if we need to, to

1 mail you something or if I, if I need, I need to put it down for the report  
2 basically so what would you like me to use.

3 **SK** Uh that's fine uh, well you know it's, I have nothing to hide so I, I can  
4 give you my, my, my personal address, it doesn't matter to me.

5 **YM** Alright well I'll tell you what; I'll get that off tape so that way it doesn't  
6 get out everywhere. Um is there anything else before we shut the  
7 tape off? Um that you feel is pertinent, that you wanted to share with  
8 us about uh conversations with Cindy or, or any of the, I guess the  
9 players in this, in this investigation?

10 **SK** No I, I and I, you know I, I think everything has been pretty much  
11 squared away and, and everything has been covered.

12 **YM** Okay.

13 **SK** You know like I said uh, uh you know I had Cindy yesterday that uh  
14 kept texting me um you know wanting to, to get their uh her hands on  
15 uh the report that uh will be sent to, to you guys and that, I, I'm, I'm  
16 not in any position to uh afford her any information.

17 **YM** Would you be able to forward the text messages as well? Any,  
18 basically we're looking for any communication uh that you have with,  
19 with Cindy if it's possible to forward it. I know um we've been able to  
20 get text messages from several of Casey's friends in this  
21 investigation. Is that something that you'd be able to do for us as  
22 well?

22 **SK** Yeah I can do that as well.

23 **YM** Oh that'd be great.

24 **SK** That's fine.

1 **YM** Mr. Krause do you swear and affirm everything you just told us is the  
2 truth?

3 **SK** Yes.

4 **YM** Okay I'm gonna stop the tape now; it's uh 1156.


